The subject(s) of the meeting are as follows:



Engineering Etc. including water/wastewater systems, drainage and detention, costs, plans, specifications, advertisements, bids, awards/revocations, insurance, contracts, change orders, estimates/payments, delays/damages, inspections, acceptances, etc., current work, defects/repairs/rehabilitation, etc., asset management and capital improvement programs (and financing), system loading/capacities, developer-builder projects (including Le-Vu clinic and event center project on Hargrave and SH 249, U-Haul Moving & Storage on FM 1960 at Cutten, as well as other developer-builder projects) and related matters; also records management, "cloud" storage, engineering records, email, and related matters, also including:

---Collapsed manhole and related sanitary sewer facilities near the intersection of Paragon Court and Champions Centre Drive, Houston, Texas 77069, including bypassing, repairs, replacement, re-routing, easements, access, contracts and related matters,

2. Proposed FM 1960 Project (TxDOT) including design, construction, takings, utilities, relocations, drainage, etc.; District facilities and property; purchase, exchange, lease, or value of real property; litigation; agreements; legal representation; and related matters.

Important: (1) Each subject listed above includes discussion, consideration, action, etc. (2) Subjects may be taken up in the order listed or in another order and may be taken up more than once during the meeting. (3) Each subject listed above includes an executive or closed session to the extent allowed by: (i) Section 551.071, Texas Government Code for attorney consultations to seek advice about pending or contemplated litigation or a settlement offer, or a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551, Texas Government Code, or (ii) Section 551.072, Texas Government Code for deliberating purchase, exchange, lease, or value of real property. (4) If a quorum is not present, those present may form an ad hoc committee to discuss, consider and act upon the subjects listed above.
